



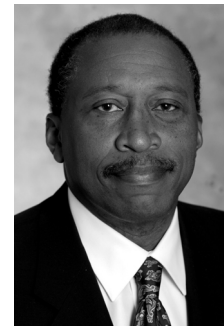
## CAREY R. DUNNE

### John J. McCloy Memorial Award

Carey R. Dunne is a partner in Davis Polk & Wardwell's Litigation Department and a member of the firm's Management Committee. He represents clients in a wide variety of criminal, civil and regulatory matters, including grand jury inquiries, internal investigations, enforcement actions by state and federal agencies, and complex commercial disputes. He recently obtained a jury verdict of acquittal in the murder trial of Lonnie Jones, a *pro bono* client of his firm, clearing him of all charges and securing his release from prison, where he had been wrongly held for more than five years.

Mr. Dunne has a longstanding commitment to improving the administration of justice. He is Chair of Chief Judge Judith S. Kaye's Special Commission on the Future of the New York State Courts and is Chair of the Judiciary Committee of the New York City Bar Association, where he has also served as Vice President and member of the Executive Committee. He previously served on Chief Judge Kaye's Commission on the Future of Indigent Defense Services, and was Chief Counsel to the New York State Commission on Drugs and the Courts. He is a director of the National Center for Law and Economic Justice, and has been a trustee of the Federal Bar Council and a director of the Legal Aid Society. He is a former director of the Fund for Modern Courts, where he chaired the Task Force on Judicial Selection.

He is Past Vice President, New York City Bar Association; Past Vice President, Federal Bar Council; Past Vice President, National Black Prosecutors Association; and Past Co-Chair, Criminal Law Committee, Litigation Section, ABA.
